Proceedings conducted at this meeting are being conducted pursuant to the provisions of the Michigan Open Meetings Act and Executive Order 2020-75 (COVID-19) and 2020-96 (Stay-At-Home) and any subsequent amendment, extension, or order allowing flexibility in complying with the Michigan Open Meetings Act issued by Governor Gretchen Whitmer.

  - c. The Chairman may call upon the applicant or staff to provide additional information regarding any matter prior to opening Public Comment.
  - d. The Chairman will call on participating members of the public during Public Comment by the name on your screen or your phone number if calling in.
  - e. Please keep all microphones/audio muted when you are not intentionally speaking to allow for less interruption.
  - f. If you would like to speak as a member of the public, please either raise your hand electronically by using the 'raise hand' feature on the app, or if you have video, raise your hand in your screen.
  - g. Participants connected by phone only will be called upon to speak during public comment periods.
  - h. All votes shall be taken by roll call to ensure all participants are able to recognize who is voting. The Secretary should tally each vote and follow a vote by speaking the total for and against, and whether the motion passes or fails.
